Keep essential elements in mind (family/context story; baby in mind; teaming/cross-discipline collaboration/alliances; parallel process; etc)- possibility of highlighting collaborative alliance, parallel process, professional use of self Keep structural characteristics in mind: confidentiality, regularity, creating a space, listening

Highlight dilemmas: Organizational opportunities and dilemmas; roles and responsibilities. Illustrative dilemmas:

- -What do you do when a participant does not attend regularly?
- -What happens when participants work together (have conflict) outside the supervision?
- -What happens when you want/need to talk about a dilemma with a person "who everyone knows"? or when people represent agencies who are competitors? How do we balance administrative and reflective roles?

10 mins clarifying questions/comments from large group (consider connections to essential elements)

45 mins supervision RESUMED /5 minutes of quiet
